ORDER GRANTING JOINT
MOTION OF DEFENDANTS
UNIVERSITY OF WASHINGTON
AND ANGELINA GODOY, AND
PLAINTIFFS COWLITZ COUNTY
AND COWLITZ COUNTY YOUTH
SERVICES CENTER, FOR RELIEF
FROM DEADLINE TO RESPOND
TO UNITED STATES’ MOTION
FOR SUMMARY JUDGMENT

THIS MATTER came on before the Court on the joint motion of Defendants University of Washington and Dr. Angelina Godoy and Plaintiffs Cowlitz County and Cowlitz County Youth Services Center, for relief from their deadline to respond to the United States’ pending cross-motion for summary judgment (Dkt. 21, “MSJ”).


Upon due consideration of the parties’ briefing on the issue, the associated pleadings, and relevant law, and for good cause shown, the Court GRANTS the Motion and ORDERS that:

(1) The MSJ is removed from the March 13, 2020, motion calendar and will not be considered on that date.

1 (2) The deadline for any response to the MSJ is continued. A new deadline and
2 briefing schedule will be set, if necessary, after the Court rules on (a) Defendants' pending
3 motion to remand the action to state court (Dkt. 17), and (b) if remand is denied, Plaintiffs'
4 motion to dismiss or strike the United States' pleading (Dkt. 15).

5 (3) If the matter is not remanded, the parties are directed to submit (jointly if
6 possible) a proposed revised briefing schedule no later than 21 days after the Court enters an
7 order resolving the latter of the pending motions noted in the preceding paragraphs. The
8 proposed schedule shall provide the parties sufficient time to address any remaining joinder,
9 pleading and other procedural issues, and the merits of the MSJ.
