### Narrative

**Report Title: Hunger Strike at NWDC - Seattle Field Office**

On December 13, 2017, at or about 1300hrs, ICE detainee (b)(6); (b)(7)(C) a 28 year old national of Cuba (b)(6); (b)(7)(C) missed his 9th consecutive meal (lunch) at the Northwest Detention Center (NWDC) in Tacoma, WA. (b)(6); (b)(7)(C) is currently housed in segregation and is being monitored by Immigration Health Service Corps (IHSC) and GEO staff.

(b)(6); (b)(7)(C) states that he is on a hunger strike because he does not like the food and does not agree with the bond set in his case nor does he believe he should be in custody. As (b)(6); (b)(7)(C) is in the segregation unit, he has no access to commissary.

(b)(6); (b)(7)(C) (b)(6); (b)(7)(C) was ordered removed to Cuba by an IJ on 12/5/2017 with appeals waived by both parties. (b)(6); (b)(7)(C) is currently in the removal period subject to detention while efforts to remove are ongoing with the Government of Cuba.
